QUELLES OPTIONS INTERNATIONALES ?

➤ Marie Skłodowska-Curie Actions (European Commission)

1. **European Postdoctoral Fellowships.** They are open to researchers moving within Europe to pursue their research career. These fellowships take place in an EU Member State or Horizon Europe Associated Country and can last between 1 and 2 years. Researchers of any nationality can apply.
 2. **Global Postdoctoral Fellowships.** They fund the mobility of researchers outside Europe. The fellowship lasts between 2 to 3 years, of which the first 1 to 2 years will be spent in a non-associated Third Country, followed by a mandatory return phase of 1 year to an organisation based in an EU Member State or Horizon Europe Associated Country. Only nationals or long-term residents of the EU Member States or Horizon Europe Associated Countries can apply.

QUELLES OPTIONS INTERNATIONALES ?

➤ Humboldt Research Fellowships for Postdoctoral Researchers

- ➔ The Humboldt Research Fellowship for researchers of all nationalities and research areas: We support you – **postdoctoral** and **experienced researchers** – with your research in Germany.
- ➔ In providing Humboldt Research Fellowships for postdoctoral researchers, the Alexander von Humboldt Foundation enables highly-qualified scientists and scholars from abroad who are just embarking on their academic careers and who completed their doctorates less than four years ago to spend extended periods of research (**6–24 months**) in Germany. Scientists and scholars from all disciplines and countries may apply.

QUELLES OPTIONS INTERNATIONALES ?

- Newton International Fellowships (The British Academy)
 - ➔ The Newton International Fellowships enable researchers to work for **two years** at a UK institution with the aim of fostering long-term international collaborations.
 - ➔ PhD, or final stages of their PhD; **no more than 7 years** of active full time postdoctoral experience at the time of application; be working outside the UK; not hold UK citizenship; be competent in oral and written English; have a clearly defined and mutually-beneficial research proposal agreed with a UK host researcher.

- Juan de la Cierva (Agencia Estatal de Investigación)
 - ➔ Formación (doctorados en los **dos últimos años**). Necesita un grupo de investigación que le apoye.

- Ramon y Cajal (Agencia Estatal de Investigación)
 - ➔ Dos tipos, para jóvenes y para avanzados. No necesita un grupo que le apoye.

QUELLES OPTIONS EN FRANCE ?

- The Young Researcher Prize (The Foundation des Treilles)
 - ➔ The Foundation awards about 20 annual grants to young researchers coming from France and abroad. They can either be doctoral students finishing their thesis or postgraduates carrying out research in France.
 - ➔ Candidates must be under 35 years old and should not have submitted a former rejected application.
 - ➔ Prizes of up to 20 000 € are awarded for a one year period. One to two grants will be awarded specifically to researchers finishing postdoctoral work abroad and wishing to return to France.

QUELLES OPTIONS EN FRANCE ?

- Allocations post-doctorales (Fondation Fyssen)
 - ➔ Les allocations d'études s'adressent à des chercheurs de niveau post-doctoral, travaillant dans les disciplines de recherche telles que l'éthologie, la psychologie, la paléontologie, l'archéologie, l'anthropologie sociale et la neurobiologie
 - ➔ Ces allocations sont attribuées à des chercheurs de toutes nationalités, titulaires d'un doctorat étranger et qui souhaitent réaliser leur projet dans un laboratoire en France; ou titulaires d'un doctorat français qui souhaitent réaliser leur projet dans un laboratoire à l'étranger (sont exclus les pays de co-tutelle)
